

## PLEASE READ... July 8, 2021 BETHANY MANOR UPDATE REGARDING STEP 3 OF THE RE-OPENING ROADMAP

You are receiving this communication because you are a resident of Bethany, or you have provided, and/or a Bethany resident(s) has provided your email address as they have identified you as their family/friend contact person.

The provincial government has indicated that July 11 is the date for the lifting of remaining COVID-19 restrictions according to *Step 3* of the *Re-Opening Roadmap*. This communique seeks to articulate what that means for our residents in practical terms.

- Beginning Sunday, July 11, mask wearing will no longer be mandatory! We encourage residents and their guests to feel free to continue wearing a mask and we ask that all unvaccinated residents and guests continue wearing a mask. We strongly encourage all residents and visitors to get fully vaccinated if they have not already done so.
- Continue to monitor your health and do not venture into common spaces/activity rooms, the dining room or Bistro, if you are not feeling well. Please continue to practice good hand hygiene.
- Capacity limits for activity/exercise rooms will end, beginning on July 11.
- Our Dining Room:
  - welcomes all remaining *monthly meal pass holders* beginning on **Wednesday, July 14**. All meals will be provided in the dining room, instead of meals by delivery.
    - However, residents with monthly meal passes should not attend the dining room if they are ill or have been in close contact with someone who is ill, particularly with suspected or known cases of COVID-19. In these circumstances, meal delivery will be available for up to 14 days to the resident's suite at no additional cost.
  - welcomes individual *meal ticket holders* beginning on **Monday, July 19**. Meal delivery for individual meal ticket holders will end at that time. All meals will be available in the dining room.
  - welcomes *guests* (non-residents) beginning on **Wednesday, July 21**.
- For reservations for meal ticket users, residents and guests, there will be a [binder with sign-up sheets in the Bethany Place lobby](#), which will be removed 2 days in advance of the meal. Please do not call the Kitchen for meal reservations.
- We encourage that you use tickets only; prepurchase tickets at the Bethany main office rather than pay cash in the dining room.
- Dining room menus will be included in the monthly newsletter again, starting with the August newsletter, and posted on bulletin boards throughout Bethany and on the Bethany website.
- For all meal tickets users, residents, and guests, you should not attend the dining room if you are ill or have been in close contact with someone who is ill, particularly with suspected or known cases of COVID-19.
- The Bistro will begin offering dine-in lunch service on Wednesdays, beginning on **July 21**, in the *Manor Multi-Purpose Room* (entry from the 110 lobby side).
- The Villa continues to be off-limits to general through-traffic as anyone entering the Villa must be pre-screened. Please contact the Resident Services Aide at 306-956-7726 if you have any questions.
