





To qualify for accommodation in a Bethany Manor rental unit, applicants need to be at least age fifty-five and able to live independently. Applicants are contacted in the order applications are received. Evidence of income will be required at time of admission; however, suites are available to anyone of any income level. All residents need to pay monthly rent as set by the Board of Directors. Applications for wheelchair-friendly modified rental units will be given priority for wheelchair-friendly modified suites. There is one waiting list for both Phase 1 and Phase 2 rentals.

To qualify for accommodation in a Bethany Place rental unit, applicants need to be at least age fifty-five and able to live independently. Applicants are contacted in the order applications are received. Evidence of income will be required at time of admission; however, suites are available to anyone of any income level. All residents need to pay monthly rent as set by the Board of Directors. Bethany Place rents are determined by square footage and all units are one bedroom.

To qualify for accommodation in a rental townhouse, applicants need to be at least age fifty-five and able to live independently. Applicants are contacted in the order applications are received. 




One-Bedroom
