I/We hereby authorize a representative of Bethany to investigate any or all of the statements made herein, being fully aware that discovery of any false statement will jeopardize any further consideration of my/our application.

Should this application be accepted, I/We hereby undertake to ensure that the terms as set forth in the lease will be strictly carried out and that all fees will be promptly paid.

I/We acknowledge and accept that Bethany is a non-smoking and scent-free facility and that no pets are permitted.

For all Bethany Independent Living housing, it is imperative that applicants do not exhibit severe signs of mental impairment (i.e., dementia, Alzheimer's Disease) at time of admission. If concerns are identified throughout the application process, Bethany has the sole authority to determine a resident's independence.

A \$200 <u>non-refundable</u> application fee is required when applying for independent Life Lease housing. This covers administration costs related to Bethany offering up to three separate Life Lease units to the applicant. If the applicant declines the first Life Lease unit offered, the fee is forfeited but the applicant continues on the waiting list. However, if the applicant accepts the <u>first Life Lease unit offered</u>, the fee is refunded.

Whenever three (3) Life Lease units have been offered and declined, a new \$200 application fee is required to stay on any Life Lease waiting list(s). Requesting removal from all Life Lease waiting lists constitutes the forfeiture of the application fee.
